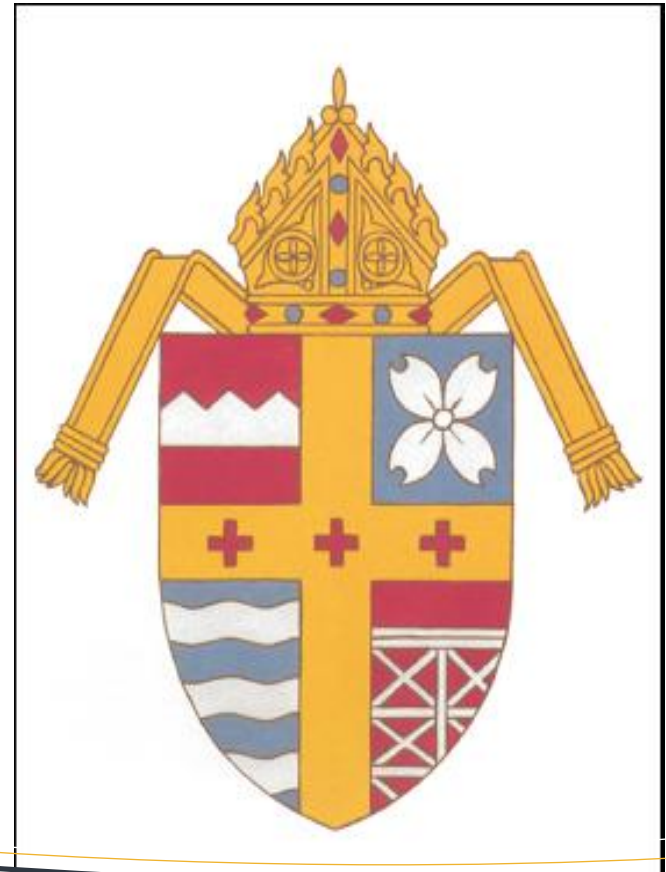




PRAYERFUL CONSIDERATION

We ask that each family prayerfully consider agreeing to make a tax deductible contribution to the KRCSOF by checking Box 1a or Box 1b on their Stewardship/Parish Contribution Form.

Thank you for your consideration of helping the children from Catholic families most in need experience the spiritual and academic advantages of a Catholic school education.



In checking **Box 1a**, you agree to make a tax deductible contribution to the KRCSOF in an amount equal to your family's standard parish contribution. *(One-Child Family-\$225, Two-Child Family-\$1,150, Three-Child Family-\$3,425, Four or More Child Family-\$6,200).*

In checking **Box 1b**, you agree to make a tax deductible contribution to the KRCSOF in an amount of your choice.

You will receive detailed instructions for payment of your contribution from the SHCS Business Office, but some basic information:

- Contributions should be made payable to the Diocese of Knoxville and sent to the SHCS Business Office.
- You may make your contribution in a single payment or 10 monthly payments, but it will not be included in your payments to the school.
- Acknowledgements of contributions will be sent from the SHCS Business Office.

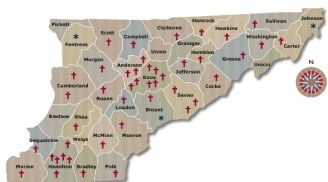

the whole community and is therefore the responsibility of the whole community. The KRCSOF was established to more equitably distribute the cost of Catholic school education among the Knoxville area parishes.

PARISH CONTRIBUTION

The majority of monies in the KRCSOF are provided by the eight Knoxville parishes which agree to support this fund: All Saints, Holy Ghost, Immaculate Conception, Sacred Heart

Cathedral, St. John Neumann, Our Lady of Fatima, St. Albert the Great, and St. Joseph-Norris. These eight parishes contribute approximately \$2 million dollars to the KRSCOF. Parishes have only the funds received in their offertory to support all of their ministries, and the number of families needing supplemental tuition assistance is increasing.

In 2009-10, there are 1,580 Catholic students attending Knoxville Catholic High School, Sacred

Heart Cathedral School, St. John Neumann School and St. Joseph School. The KRCSOF will distribute \$1.0 million dollars in standard parish contribution toward tuition to the four schools.

337 CATHOLIC STUDENTS, OR, about 21%, receive supplemental tuition assistance. The KRCSOF will distribute over \$1.0 million dollars in supplemental tuition assistance to the four schools or an average of \$3,100 for each of the students receiving supplemental tuition assistance.
