- Single payment of tuition directly to each school. This payment must be received on or before the date designated by the school. A discount *may* be applied for this option. Discount applies to tuition only. Please note that fees and books may be included in amount due. If the single payment is not made by the designated date for the school, tuition must be paid through the school's electronic monthly payment plan.
- Monthly payment plan. Electronic bank draft of tuition each month. Please note that fees and books may be included in the monthly amount due.

***Note: Before registration can be completed, a Catholic family must have the Parish Affiliation Certification (bottom of this form) signed by your Pastor or his designee. This form must be completed by the published deadline in your school registration packet. Forms and instructions for requesting Supplemental Tuition Support are available from your parish or school business offices.**
